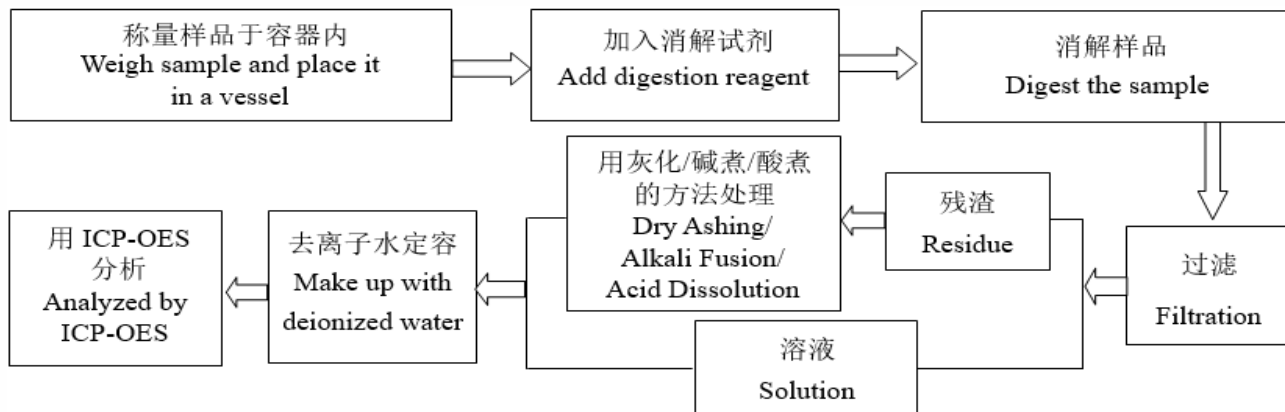

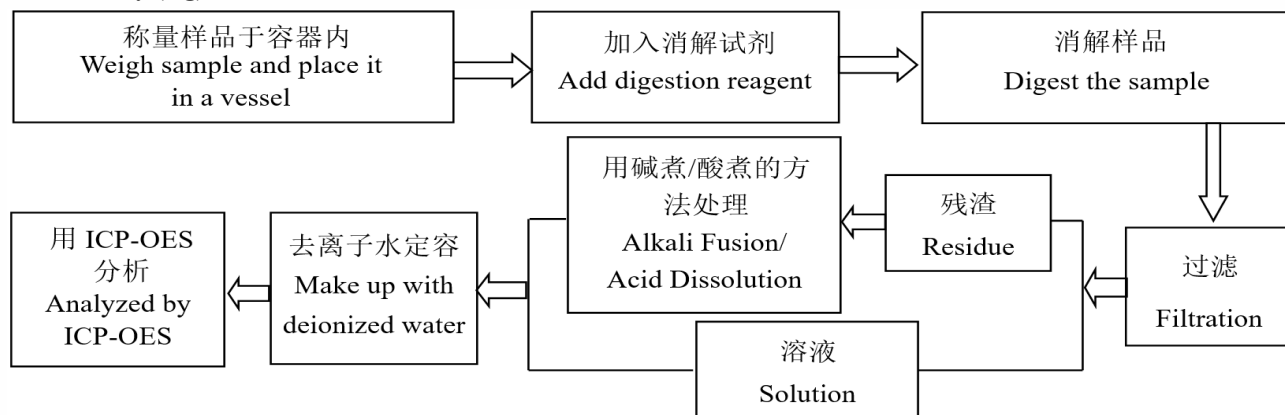

#### Lead (Pb), Cadmium (Cd), Chromium (Cr)



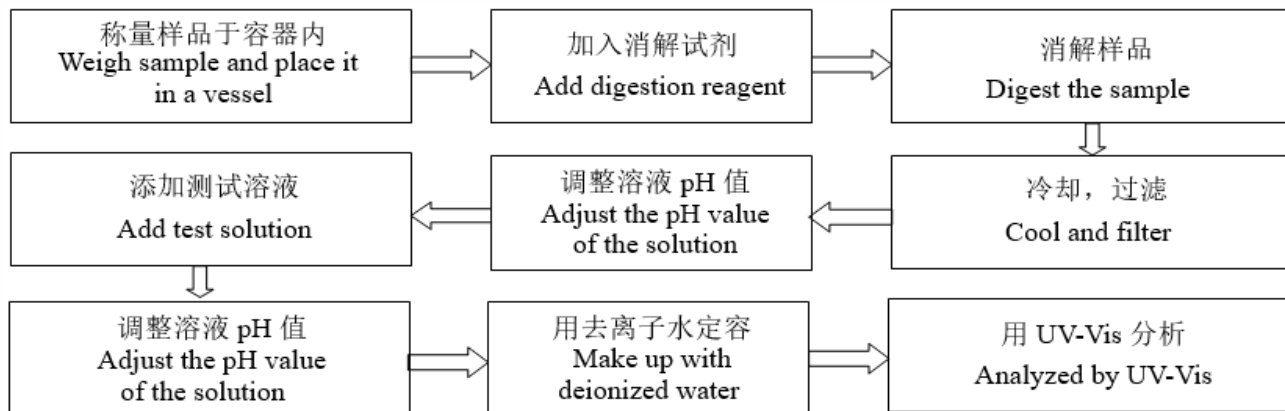

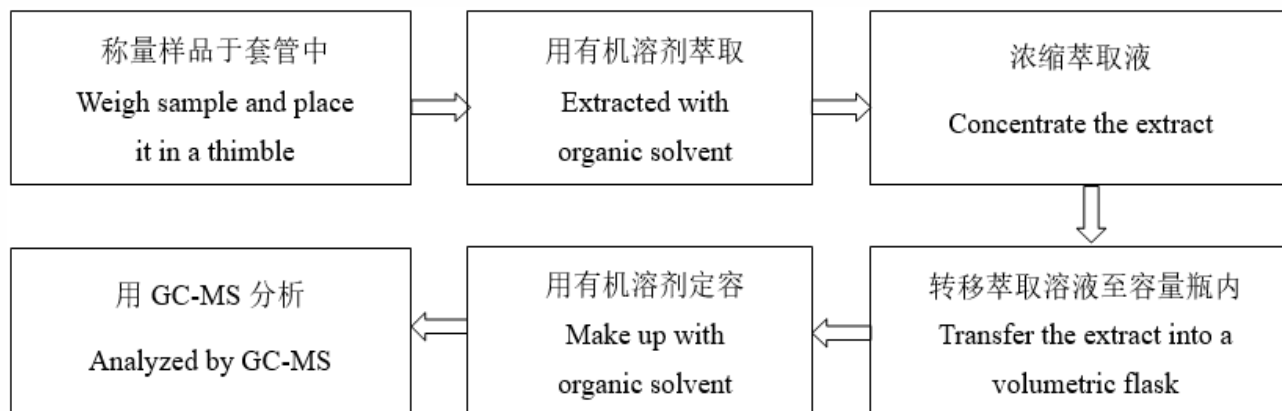

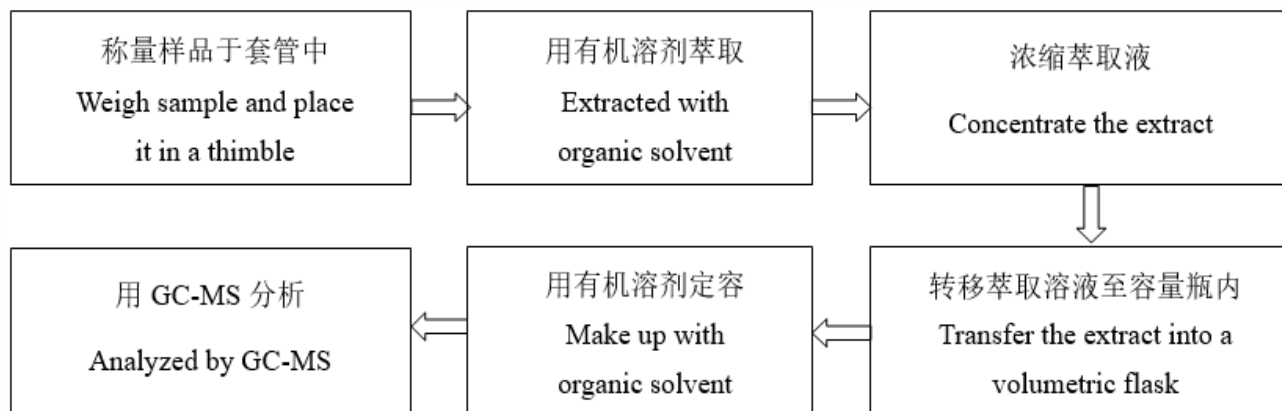
